I hereby grant this licence under Part 8 of the Act to operate a Special Passenger Vehicle (Rideshare) vehicle. This licence is valid from **{DATE}** up to and including **{DATE}** and shall only be used to operate the motor vehicle (the vehicle) displaying the registration number plate **{XXXXXX}** issued under the *Motor Vehicles Act*.

This licence is subject to the following conditions that:

1. The vehicle is operated in accordance with the *Commercial Passenger (Road) Transport Act* (the Act), the Ridesharing Regulations, any code of conduct and standards made from time to time that apply to rideshare vehicles;
2. The vehicle must have affixed on it, the adhesive label issued in respect to this licence by the Director of Commercial Passenger (Road) Transport (the Director). The label must be securely attached to the bottom corner passenger side of the vehicle windscreen to afford ready view of the label's details when viewed from outside of the vehicle;
3. The vehicle must only accept a hiring from a rideshare platform on the register of rideshare platforms maintained by the Director and made available to the public via the Northern Territory Government's website;
4. The vehicle must not be available for hire or reward unless the vehicle and driver is registered with, and is logged as operating under, an approved platform;
5. The vehicle must not park or stand for hire and cannot respond to rank or hail hirings;
6. The vehicle, when operating for hire or reward, must only be driven by a person holding:
 - a. an 'h' endorsed driver licence issued under the *Motor Vehicles Act*, and
 - b. an identity card issued under the Act for the category of Special Passenger Vehicle (Rideshare).

7. Records relevant to the operation of the vehicle must be produced to the Director upon request by the holder of this licence;
8. The vehicle is kept in a roadworthy condition at all times and is presented for inspection at intervals not exceeding 12 months unless otherwise approved by the Registrar of Motor Vehicles;
9. A copy of this licence must be kept in the vehicle at all times and be presented to an Inspector appointed under the Act or a Police member upon request. Presentation of either a paper based or electronic copy of this licence would satisfy this condition;
10. Notwithstanding condition 2 of this licence, the vehicle must not display any form of advertising or marking which would indicate to a member of the public the vehicle is available for hire; and
11. The holder of this licence is to ensure that any injury to a person arising out of or in the course of the person's engagement to drive the rideshare vehicle endorsed on this licence is covered by a policy of insurance.

Important Note

The licence holder is responsible for any failure to comply with the obligations imposed upon the operator of the vehicle by the *Commercial Passenger (Road) Transport Act*, the regulations made under the Act, any code of conduct, and standards, made from time to time under the Act that apply to rideshare vehicles. Failure to comply with these laws or any condition in this licence is a contravention of this licence and may result in the cancellation or suspension of this licence.
